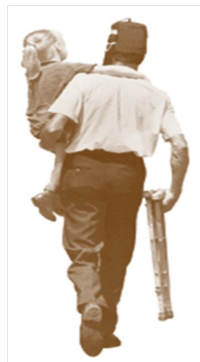


First let me say thank you to all the Nobles and their Ladies for what you do to make Cahaba Shrine great.



We teach the boys responsibility and planning in all their endeavors and we have been greatly assisted in these efforts by everyone at Cahaba Shrine. We have hosted Pancake Breakfast fundraisers, Fundraising tickets sales as well as various other installations at the temple. We strive to be of assistance in any way we can to the Nobles of Cahaba Shrine. We were glad to help with the 50/50 ticket sales at the Sportsman Giveaway this year and grateful for the opportunity to help buss tables at the Potentates Ball. This work by the boys and the advisors has taught them some important lessons of being responsible and helping their fellow men and ladies. I hope that they are able to see and comprehend some of the great things that Cahaba Shrine does for the patients of the Shriner Hospitals.

For those of you that do not know DeMolay is a young men's organization started by Noble Frank S. Land in 1919 in Kansas City, Missouri. Dad Land as he came to be known, was friends with a young man named Louis Lower. Louis's Dad had passed away and Dad Land took the time to listen to Louis, to learn about his dreams and decided to help him. In the mean time Dad Land learned that there were other young men that sought companionship and he thought about forming an organization to help young men, and hence what we know today as DeMolay was formed. Louis and 8 other young men met with Dad Land at the Kansas City Scottish Rite Temple, where Dad Land was the Social Service Director. It was natural for them to identify themselves in some way as a Fraternity of Freemasonry. The group needed a name and Dad Land provided them with the story of Jacques DeMolay, who would rather die than betray the trust of his Brothers in the Knights Templar. The boys decided to take the name of the Martyr DeMolay and they have been this organization ever since.

The group has 7 cardinal virtues which they strive to live by. Filial Love (love of Parents), Reverence for Sacred Things, Courtesy, Comradeship, Fidelity, Cleanness and Patriotism. The boys are responsible for creating a plan of their activities, meetings and executing these things. There are Advisors, some of which are Masons, that guide and help them along the way. We want to teach them how to be leaders and to be productive members of society as a whole when they reach the age of manhood.

You do not have to be a son of a Mason to join, any young man between the ages of 12 and 21 can join. There are Chapters in Huntsville, Princeton, Birmingham, Montgomery and Mobile. We encourage you to find the Chapter near you and share your words of wisdom with these young men. Level 1 – Upon creation or restoration of one member, the top-line signer will receive a postcard and Just One pin from Imperial Potentate Jeff Sowder.

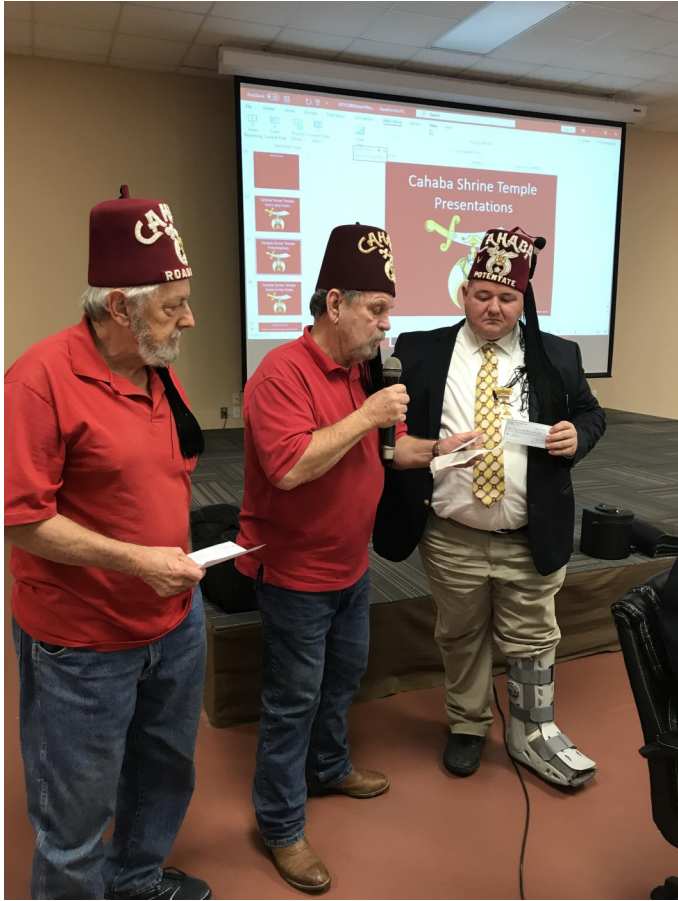
Level 2 – Upon bringing in two members, the top-line signer will be listed in the Shriner Magazine.

SPECIAL PURPOSE FUNDS

Inasmuch as Shriners Hospitals for Children are the primary charitable concern of the Order, it is necessary that Shriners International exert every effort to insure that Shriners Hospitals for Children are financially stable and have adequate funding for operational needs. The reports of the Special Purpose Funds Committee have indicated to the Imperial Potentate and the board of directors that some temples, either directly or through Special Purpose Funds, have accumulated charitable funds and assets which are in excess of amounts reasonably needed for transportation of patients and could be better utilized for our orthopedic and burns hospitals if they were administered together with other endowment funds and accounts of Shriners Hospitals for Children. Now, therefore, by virtue of the authority in me vested by §206.5(a)(4) of the bylaws of Shriners International, IT IS HEREBY ORDERED:

1. **Sole Charity:** Neither the temples, their shrine clubs, their units, nor their membership shall solicit charitable gifts or bequests for any purposes, organizations, or charities other than Shriners Hospitals for Children, except as may be allowed by §335.4(b) of the bylaws of Shriners International and the provisions of paragraph 2(a)(1) of Fundraising Activities herein.

2. **Restricted Fund.** A temple shall maintain a separate bank account or accounts, designated Shrine Hospital Patient Transportation Fund, for disbursements and expenses, in accordance with the provisions of the Shrine Hospital Patient Transportation Fund herein. (a) All receipts and disbursements related to charitable activities shall be clearly designated and classified as such in the books of all temples, temple affiliated corporations, shrine clubs, committees, boards, or other entities subject to the supervision or control of any temple; and such books of accounts shall be reviewed annually in a manner consistent with the requirements of §334.6 of the bylaws of Shriners International. (b) The custody and administration of all charitable funds and assets under the control of any temple, including those of temple affiliated corporations, shrine clubs, committees, boards, and other entities subject to the supervision or control of any temple, shall be the responsibility of the board of directors who are charged with the custody and administration of the general funds of the temple. The temple shall maintain a separate bank account or accounts, designated Shrine Hospital Patient Transportation Fund to make deposits and disbursements for the purposes herein authorized. Interest earned on the restricted fund balance must be credited to the hospital patient fund account. (c) Any temple may be required by the Imperial Potentate to show cause why any part of its charitable funds or assets not reasonably needed for purposes permitted under paragraph 1 hereof should not be transferred to Shriners Hospitals for Children; and the board of directors of the Iowa Corporation shall have the power to require the transfer to Shriners Hospitals for Children of any such charitable funds or assets not reasonably needed for the purposes permitted under this paragraph after the temple has been given a reasonable opportunity to be heard by the board of directors or by a committee thereof with respect to the matter. Updated MAY 2016 6-2 (d) After a fundraising event for the benefit of Shriners Hospitals has been held, and upon written request to, and written authorization by, the chairmen of the boards of directors and trustees of Shriners Hospitals for Children, up to one-half of the net proceeds of a designated fundraising activity may be held by a temple to be used exclusively for disbursements and expenses in accordance with the provisions of Shrine Hospital Patient Transportation Fund herein. Such retained funds, including interest earned on the funds, shall be maintained pursuant to the Uniform Chart of Accounts for Shrine Temples, in a separate account designated as the "Shrine Hospital Patient Transportation Fund." The balance in the fund shall not exceed twice the amount of the expenditures made from such fund during the preceding year, unless the chairmen of the boards of directors and trustees so authorize. Any sums in excess of that shall be turned over to Shriners Hospitals for Children. If for any reason this fund should terminate, the entire balance in the fund shall revert to Shriners Hospitals for Children. (e) In the event a temple is experiencing an undue hardship in meeting the expenses enumerated in subparagraph (g), its written request should so specify. When such a request is received, it shall be reviewed by the Executive Vice President and the Director of Temple Accounting, and they shall issue their recommendation thereon. Thereafter, if the chairmen of the boards of directors and trustees, after a review of all of the circumstances, make a finding of undue hardship, they may authorize the temple to retain a percentage in excess of 50% of the net proceeds of the designated fundraising activity, solely for the uses enumerated in subparagraph (g). This authorization shall apply only to a specific fundraising event or activity, and that event or activity shall not have a duration of longer than one year. (f) Prior to the granting of authorization to retain a fund balance in excess of twice the amount of expenditures made from the fund during the preceding year, or to retain funds from fundraising events, as outlined under subparagraphs (g) and (h) hereof, the temple must submit its request in writing and must have on file with Shriners International or attach to the request: (1) Reviewed statements of its transportation fund for the past three years, such statements to include a statement of receipts and disbursements and balance sheet as of the date of the last review. (2) A summary of the total receipts and disbursements for each month since the last reviewed statement and a current month end balance sheet. (g) In the event a temple has insufficient independent funds and ability to purchase a hospital van and it desires to use moneys from a charitable fundraising activity or from its Shrine Hospital Patient Transportation Fund, or both, it shall make a request pursuant to the Shrine Hospital Patient Transportation Fund provisions in any General Order. (h) A temple with the approval of its board of directors, may make disbursements from its temple hospital transportation fund to Shriners Hospitals for Children and to the Headquarters Emergent Transportation Fund. (i) No permission will be given for any fundraising event or the use of the name Shriners Hospitals for Children or for the retention of funds if any Shrine Charity Activity (CAF) form for a previous fundraising event authorized to be held by the temple or any of its shrine clubs or units is remaining outstanding for more than 120 days after the event was held at the time the request is made.

3. **Compliance with Law.** All fundraising activities must comply with the law of the land and Shrine law, including the Fundraising Activities provisions of any General Order.

210.7 Code of Ethics:

The officers and directors of Shriners International, an Iowa Corporation, and all who may be elected or appointed to positions of authority, in order to discharge the responsibility bestowed upon them by the Representatives, and to maintain the integrity to the Order, and all Shrine Temples, their elected Divan members, their appointed Officers and all Nobility, shall abide by this Code of Ethics.

- (a) Obey the law of the land and the Articles of Incorporation and bylaws of the Order, adhering to the spirit as well as the letter thereof.
- (b) Demonstrate the higher standards of personal integrity, truthfulness and honesty in all their fraternal activities; administer the Order's affairs with impartiality, efficiency and effectiveness and in a manner that enhances its good name and mission.
- (c) Be certain that their information is accurate when speaking on behalf of the Order; disclose when they are stating their personal opinions; and be scrupulous in the representation of their authority and avoid misleading those with whom they deal.
- (d) Approach their organizational and operational duties with a positive attitude and constructively support open communication, creativity, dedication and compassion; bring credit to the Order by their public demeanor; accept as a personal duty the responsibility to remain informed on important and critical issues affecting the Order; and avoid accepting an assignment if they cannot effectively, competently and timely discharge the responsibilities of the assignment.
- (e) Exercise their independent judgment in the best interest of the Order, and free of compromising influences of loyalties; and act responsibly and in good faith, and in a manner not designed or intended to bring them personal gain from the discharge of their fraternal duties.
- (f) Give notice, in a manner consistent with the corporation's bylaws of any duality of interest or possible conflict of interest and make it a matter of record; give notice of any direct or indirect interest in an individual or organization which is proposing or is involved in a transaction with the Order; and, thereafter, refrain from voting on the matter or transaction.
- (g) Refrain from using funds or assets of the Order for personal gain; refrain from receiving anything of value for influencing their actions; and refrain from granting or accepting favors for personal gains.
- (h) Report the unethical or inappropriate behavior of Directors or Officers to the Board of Directors, when informed resolution is not effective.
- (i) Refrain from using their official positions or influence either for or against any candidate for public office.
- (j) Serve with respect, concern, courtesy and responsiveness, recognizing that service to the Order is beyond service to themselves.

325.11 Election Regulations:

- (a) **Electioneering:** A candidate of an elected office in a Shrine temple may print, publish and circulate during the year he is seeking the elected office, a resume consisting of his educational background, his vocational history, and his Masonic and Shrine record. Except as provided in the prior sentence, the printing, publication, circulating or distribution of resolutions, letters, telegrams, tickets, email or other devices, by a unit, club, Noble, or group of Nobles, suggesting recommending, opposing or containing the names of proposed candidates for office in the temple is prohibited.
- (b) **Expenditures Prohibited:** The expenditure of money for gifts, favors, or entertainment on behalf of a candidate for elected office is prohibited.
- (c) **Violation:** For any violation of (a) or (b) the Imperial Potentate may suspend any offending Noble, and he may declare the election of the officers void and order a new election.
- (d) **Notice:** At least one week prior to the annual meeting or any election, the temple Recorder shall mail to each member a notice thereof containing this section.
